ECAC and Board of Governors (BOG) Meeting Update

• CAC members were given 4 minutes to read the October 2018 ECAC Report found in the meeting folder.

Gloria Camarillo, RCAC 5 member. attended the ECAC meeting on September 12, 2018 and reported the following:

- o New RCAC applicants were approved by the ECAC committee
- We were updated on an initiative that will decide whether to give cities and counties the freedom to expand the use of rent control.

Daisy Corona, RCAC 5 member. attended the ECAC meeting on October 10, 2018 and reported the following:

• There was a discussion that talked about the new rules that the Trump Administration is proposing that would change who is considered a "Public Charge". These changes would put more families at risk, and would affect a person's "Permanent Resident" status in the U.S.

Sofia Sulca, RCAC 5 member. attended the BOG meeting on September 6, 2018 and reported the following:

- o More surgeries are performed in hospitals, and it seems that hospitals generally prefer to do surgeries than to avoid them if possible, because it's more lucrative; patients' needs are secondary. This is alarming because with this mindset, profits are being prioritized over the well-being, and curing of patients.
- A comment from an Antelope Valley CAC member stated that disabled health plan members can receive their health benefits without the need of a lawyer, or having to place a complaint.

<u>Maria Leos, RCAC 5 member</u>, attended the BOG meeting on October 10, 2018 and reported the following:

- o Members were encouraged to go out and vote on November 6, 2018.
- o The BOG elected Ms. Hilda Perez to be the new Chair of the Governance Committee.
- o Open enrollment starts on October 15, 2018 for people interested in enrolling in Covered California.
- o Patients that get treatment at the UCLA medical center, are usually extremely sick and have some type of chronic illness that requires specialty care (e.g., cancer patient, organ transplant patients), clarified Dr. Richard Seidman, *Chief Medical Officer* at L.A. Care.
- o L.A. Care is currently going through an internal Audit.

CO&E Report

Elevating the Safety Net

• Members and public present received information on L.A. Care's "Elevating the Safety Net", an initiative to recruit qualified primary care physicians to Los Angeles County safety net. A short L.A. Care video was displayed that explained the initiative programs, and after the video members had an opportunity to go over a PowerPoint presentation included in their folders that provided more detailed information on L.A. Care's Elevating the Safety Net three grant programs: 1) Provider Recruitment Program, 2) Physicians Loan Repayment Program, and 3) The Scholarship Program, which also included a picture and a bio of the 4 students From David Geffen School of Medicine at UCLA, and the 4 students from Charles R. Drew University of Medicine and Science.

Operating Rules for The Consumer Advisory Committees of L.A. Care Health Plan

• All members received a copy of the most up to date Operating Rules. CAC members had an opportunity to review the most recent changes that were approved back in April of 2018, and were informed that these rules govern all the public advisory committees - RCAC 5 being one of them. CAC members were encouraged to contact staff if they had any questions pertaining to this most up to date document.

At-Large Member Position Elections

- Member were informed that the ECAC At-Large elections will occur during the November 14, 2018 ECAC meeting.
- RCAC members interested in running for the position will need to complete an application, attend the November ECAC meeting, and speak to the ECAC members on why they are the best candidate for the position.
- ECAC, at that time will take a vote. Those CAC members elected for the positions will have to be approved by the Board of Governors in December and will then be able to be seat as an ECAC member during the December ECAC meeting (12/12/18).
- Members were informed that there are two ECAC At-Large member positions. One represents the RCACs and the other represents the CCI Councils.
- Members reviewed the roles and responsibilities of the At-Large member position, and one CAC member completed an At-Large Member application and submitted it to L.A. Care staff. The rest of the CAC members were encouraged to reach out to Ricardo Rivas if they were interested in the position after the meeting.

Interpreting Service Member Survey

Members were informed that the Cultural & Linguistic (C&L) Services department at L.A. Care is conducting a member survey to all CAC members to get their input on the interpretation services they have received at L.A. Care meetings, trainings, and conferences. All members present completed the C&L survey and submitted it to L.A. Care staff.

Code of Conduct Training

• All members were informed that they would be receiving a Code of Conduct Training during the December/January meeting cycles.

Emergency Preparedness Presentation

• Members were informed that L.A. Care will be working with the American Red Cross to provide an emergency preparedness presentation at a future RCAC meeting for the 2018 – 2019 fiscal year. Once a date has been confirmed this information will be shared with the RCAC.

CAC Member Acknowledgement

• Members were informed that all CAC members that participated in the RCAC Work Plans for the 2017-2018 fiscal year will be acknowledged during the February/March RCAC meeting cycles. Members were also informed that CAC members that were not able to complete the minimum requirement stated in the *Member Acknowledgement Form* all members signed last year will receive a notification

by mail informing them that per our records, they did not complete their commitment for last year, and that L.A. Care does keep track of who participates and who does not – this will continue into the new 2018-2019 fiscal year.

Members were reminded that being a RCAC members also involves being an active-CAC member, involved throughout the year in all the L.A. Care activities that are provided (e.g., Conferences/Trainings, Work Plan Events, etc.).

Care staff pointed out that this is correct, and reminded everybody that if anybody is interested in receiving Acupuncture treatment, they must follow the process like any other procedure covered by their health plan, and first start with their Primary Care Physician to get an authorization & referral to a location within their health plans network; If you walk into an Acupuncture facility without a referral you will pay out-of-pocket.
