L.A. Care Updates	Agenda Lead
 RCAC Chairperson Updates Maria Angel Refugio provided an update from the December 11, 2024, Temporary Transitional Executive Community Advisory Committee (ITECAC) and December 5, 2024, Board of Governors meetings as both committees didn't not meet in January 2025. Ms. Refugio stated Board Members, Mrs. Layla Gonzalez, and Fatima Vasquez reported Mr. John Baackes, Chief Executive Officer, stated the partnership with the Community Resource Centers and Blue Shield will continue. Dr. Alexander Li, Chief Health Equity Officer, reassured members that they will continue to receive access to healthcare services regardless of their immigration status. Mr. Baackes provided a final update regarding the growth of L.A. Care's programs regarding Covered California, Cal Medi Connect, Elevating the Safety Net and the expansion of the Community Resource Centers. Board Member, Al Ballesteros thanked Mr. Baackes for his commitment to L.A. Care since he joined the organization in 2016. Dr. Sameer Amin, Chief Medical Officer, will be proposing to the new CEO of L.A. Care his plan to expand medical services at the Community Resource Centers such as medical visits, exams, vaccinations, and other healthcare services. Ms. Refugio provided an update regarding the Hoyer Lifts. The TTECAC approved a motion to include Hoyer Lifts in their offices. This initiative aims to improve accessibility and assist patients with mobility challenges by ensuring they have the necessary support for safe and comfortable transfers during medical visits. Ms. Refugio reported that the TTECAC received a presentation on the Population Needs Assessment, which provided an overview of key health disparities and priority areas for improvement. The presentation highlighted the specific needs of diverse communities and outlined strategies to enhance access to care, address Social Determinants of Health, and improve overall health outcomes for members. - Ms. Gonzalez stated that some additional information was presented at the December 11, 2024, TTECAC meeting regarding a motion that was introduced by the RCAC 4 Chair, Silvia Poz. Ms. Gonzalez mentioned that there were a few key points they were trying to address:
 - People are not receiving enough medical attention
 - o They don't get their appointments on time
 - o They aren't given enough time to thoroughly discuss their care with their doctor
 - o The inability to access proper care is a serious issue
- Ms. Gonzalez stated that she hopes the motion goes to the Board of Governors for discussion and consideration.
- Maria Angle Refugio stated that she can bring more information to RCAC 3 once the outcome of the motion is returned to the RCACs. Ms. Refugio also mentioned that the motion was not only intended to address issues in RCAC 4 but appears to be a broader issue impacting all eight RCACs.
- Gladis Alvarez attended the December 11, 2024, TTECAC meeting and stated that she was impressed with the
 methodology regarding the well-being of African American communities, particularly mothers and adolescents.
 Ms. Alvarez stated the goal is set for either 5 or 10 years and aims to address and reduce the challenges these
 communities face. Additionally, Ms. Alvarez suggested to Maria Angel Refugio that this initiative should not be
 limited to African American communities but should extend to all young people and perhaps starting with
 education could be beneficial.
- Layla Gonzalez added to what Ms. Gladis Alvarez stated earlier and shared that over the past 10 years, statistics
 have shown that many women face serious complications during childbirth. These include hypertension, loss of
 life, and risks to newborns. Because of this, L.A. Care's goal is to reduce maternal deaths. L.A. Care shared data on
 the number of members who have lost their lives, which has only been two. L.A. Care is working to eliminate
 these tragedies and improve the quality of life for pregnant women and their families, ensuring safer births.
- Ms. Gonzalez stated this effort is important because, for many years, these women have been denied proper
 care, ignored, and overlooked. Since they experience complications at higher rates than other racial groups, the
 focus is on addressing their needs first. It's also important to remember that when improvements are made for
 one group, they often benefit others as well. While the initiative is centered on addressing disparities, its impact

will likely extend beyond just one community. Ms. Gonzalez stated L.A. Care is prioritizing this issue, as progress in one area often leads to broader improvements for all.

- Alicia Mendoza, RCAC member, stated the issue is that many women giving birth are not receiving proper
 prenatal care. While doctors are the same for everyone, some women do not follow a prenatal process. For
 example, in some cases, women have their blood pressure checked weekly and pay close attention to diabetes.
 This makes a big difference when monitoring health conditions separately.
- Ms. Mendoza stated the solution is not just about educating doctors but also about educating patients. Many
 women miss their medical appointments or do not follow proper nutrition guidelines. This contributes to the

- Tanya Lopez, RCAC member, shared that undocumented individuals are still very afraid to go to hospitals. She
 asked how the RCAC and L.A. Care can help ensure that members feel safe accessing healthcare. Although, she
 knows it's safe, there is no way to fully reassure them. She stated some members have legal status, and they may
 not experience the same fear they do. Ms. Lopez states the biggest concern is how can the RCAC support those
 members. Members should not have to avoid seeking care when they are sick.
- Ms. Lopez stated another issue is the rising cost of medications, especially for the elderly. Prescription prices
 continue to increase, and many seniors cannot afford them. With rent and other expenses, their limited income
 of \$900 to \$1,000 is not enough. As a result, many elderly folks delay in getting their medications, worsening their
 health.
- Lluvia Salazar expressed concerns about increased immigration enforcement in the community. Reports indicate
 recent check points and sightings of immigration officers in local stores such as Food 4Less and La Vallarta
 Markets. Fear is growing among undocumented individuals, including DACA recipients and others with uncertain
 immigration status. Members discussed the potential impact of immigration policies under the new presidential
 administration and how this could affect healthcare access and overall well-being in the community.
- Ms. Layla Gonzalez stated that during the pandemic, when people were hesitant to get vaccinated, L.A. Care
 launched a campaign featuring various actors and influential Latino figures to promote vaccination. Maybe L.A.
 Care can do something similar to reassure people. The fear they feel cannot be completely eliminated, and we
 can't guarantee their safety by simply telling them, however, perhaps we can assure them that seeking care will
 not put them at risk. L.A. Care could consider starting another campaign to help ease these fears and reassure the
 community.
- Alicia Mendoza stated the topic of immigration and access to care are very important points. Despite the
 expansion of Medi-Cal access to more people, including women aged 50 and older, many people still fear seeking
 medical care due to their immigration status and the threat of immigration enforcement operations.
- Frank Meza, Community Outreach Field Specialist, will work with Maria Angel Refugio to develop talking points
 addressing the issue of members being afraid to see their doctors due to immigration enforcement and
 checkpoints. Additionally, he mentioned bringing up Tonya Lopez's point about the rising cost of medications.
 These two issues appear to be concerns affecting multiple communities across Los Angeles County.

- Gladis Alvarez stated she agrees with the topics that were mentioned and it will significantly impact people's health. For example, if they are afraid to go to stores, if their health conditions prevent them from going to appointments, if they don't have proper medical equipment, or if they must choose between buying medication and food—this is a global issue that will have serious consequences.
- Additionally, Ms. Alvarez stated that she had been attending district meetings, and everyone was worried because
 the administration had promised to implement many harmful policies, including cuts to education. Schools,
 especially those that received Title 1 funding—a type of grant—depended on these funds. However, the
 administration had also promised to eliminate them.
- Thanks to this funding, children had access to free lunches. Without it, concerns arose about what would happen next. The cost of living had already risen significantly, rent prices had skyrocketed, and people had begun losing their homes. As mentioned earlier, many individuals were barely getting by on \$900 a month. Additionally, the administration had announced plans to cut social service programs, further worsening the situation. From her perspective, this was a major crisis—like a snowball that would continue to grow. It felt like a return to past hardships.

C. Community Outreach & Engagement Updates

- Decision Making and Building Consensus
 - Ramon Garcia, Community Outreach Field Specialist, reviewed two documents with the members: one
 outlining the traffic light system and the other titled Voting Methods. These documents were briefly
 discussed, and members were encouraged to take them home for further review.

- At the next meeting, members will have an opportunity to practice using these methods. Previously, Robert's Rules of Order had been used for decision-making, but to simplify the voting process within RCAC, CO&E will use a new simplified process for parliamentary procedure:
 - General Consent Used for approving meeting minutes and the agenda.
 - Ballot Voting Used for elections.
 - Color Cards This method will use green and red cards to indicate agreement or disagreement.
- Members were reminded to review the documents, bring any questions to the next meeting, and prepare for a practice session.
- There were no questions or comments from the members.

2025 Work Plan Project

- Frank Meza stated that Community Outreach & Engagement is in the process of refining the focus of the work plan project for the RCACs to ensure it aligns with L.A. Care goals and objectives.
- Mr. Meza stated he will keep the RCAC informed of any updates or developments as they become available.

- Frank Meza officially closed nominations for the RCAC Chair position. Mr. Meza stated before the elections he would provide instructions for the elections:
 - Member needs to receive 50% plus one based on the committee's attendance the day of to win the election.
 - There are currently 13 members in attendance and 50% plus one is seven.
 - Members who are running for the RCAC Chair or Vice Chair need to be present to participate in the elections.
- Mr. Meza invited all RCAC candidates to share with the committee their experience, background and goals if they are elected for the position.
 - Tanya Lopez emphasized the importance of unity, support, and standing together as a team, regardless of
 differences. She highlighted the need to assist those without a voice, especially undocumented individuals,
 and expressed a strong commitment to helping the community. Recognizing the challenges ahead, she
 encouraged members to remain united, support each other, and rely on faith to stay strong in difficult times.
 - Lluvia Salazar asked Ms. Lopez what her employment is. Ms. Lopez stated she is a volunteer, and a Certified Nurse Assistant (CNA) and she loves to help people.
 - Gladis Alvarez expressed her gratitude for the nomination and shared that it is an honor to be part of the
 team. She emphasized the importance of advocacy, particularly for the community and those who cannot
 speak for themselves. As a mother of four children, three of whom have special needs, her personal
 experiences have driven her passion for advocacy, both in schools and within the community, ensuring that
 everyone receives the support they need.
 - Lluvia Salazar made a comment stating that Gladis Alvarez and her are members of Parents Place, which is an
 organization in West Covina that supports kids with disabilities.
 - Jose Lopez expressed his gratitude for being chosen and shared his deep connection with those experiencing illness, as he has faced his own health challenges for a long time. He sees this as an opportunity to support

and motivate others, helping them navigate the life changes that come with illness while fostering a sense of unity and family within the group.

- Lluvia Salazar asked Mr. Lopez if he volunteers with other organizations and if he has been in a similar role. Mr. Lopez stated he hasn't had an opportunity to volunteer due to previous illnesses.
- Elmano Osorio was born in Africa, raised in the United Kingdom and Portugal, and is fluent in five languages.
 With experience in global missions for the United Nations, he is committed to addressing health disparities through collaborative problem-solving and advocating for an effective and accountable health plan.
- Sandra Aramburo asked Mr. Osorio if he volunteers with other organizations and if he has been in a similar role. Mr. Elmano stated he was part of the United Nations for more than 10 years and has visited other countries to help bring resources to underserved communities.
- Lluvia asked Mr. Osorio where he was born and how many languages he speaks? Mr. Elmano stated he was born in Angola in the continent of Africa, and he speaks English, Spanish, Portuguese, French and Italian.

Jose Lopez shared regarding the Real ID is an enhanced identification with higher security standards required by
the U.S. federal government. Lluvia Salazar added and stated the Real ID is for access to federal facilities, domestic
flights, and government offices. Elmano Osorio stated Real ID does not affect immigration status, is not required
for driving, and does not replace passports, visas, or other residency documents for international travel.
