Public comments submitted will be read for up to 3 minutes during the meeting. Once the meeting has started, public comment submitted in writing must be received before the agenda item is called by the Chair and staff will read those comments for up to three minutes. Chat messages submitted during the public comment period for before each item will be read for up to three minutes. If your public comment is not related to any of the agenda item topics, your

public comment will be read in the general public comment agenda item. These are extraordinary circumstances, and the process for public comment is evolving and may change at future meetings. We thank you for your patience.
